Average time to complete

Estates that fall within this range are dealt with within 6 to 12 months. Typically, obtaining the Grant of Probate takes 4 to 5 months, however we have been informed it is now taking the Probate Registry a minimum of 16-20 weeks to issue Grants upon receipt of the application. Collecting assets and settling liabilities can take between 2 to 4 months. If inheritance tax is due we must first lodge the Inheritance Tax Return at HMRC and then wait a period of 20 working days before then lodging the application to include the Legal Statement and original will to the Probate Registry. The above referenced timescales would apply. It can usually take between 5 to 8 months to receive clearance from HMRC. Once this has been received, we can distribute the assets, which normally takes 1 to 2 months.

Potential additional costs:

If the estate consists of any share holdings (stocks and bonds) and has more than five bank accounts and four beneficiaries there is likely to be additional costs that could range significantly depending on the estate and how it is to be dealt with.
